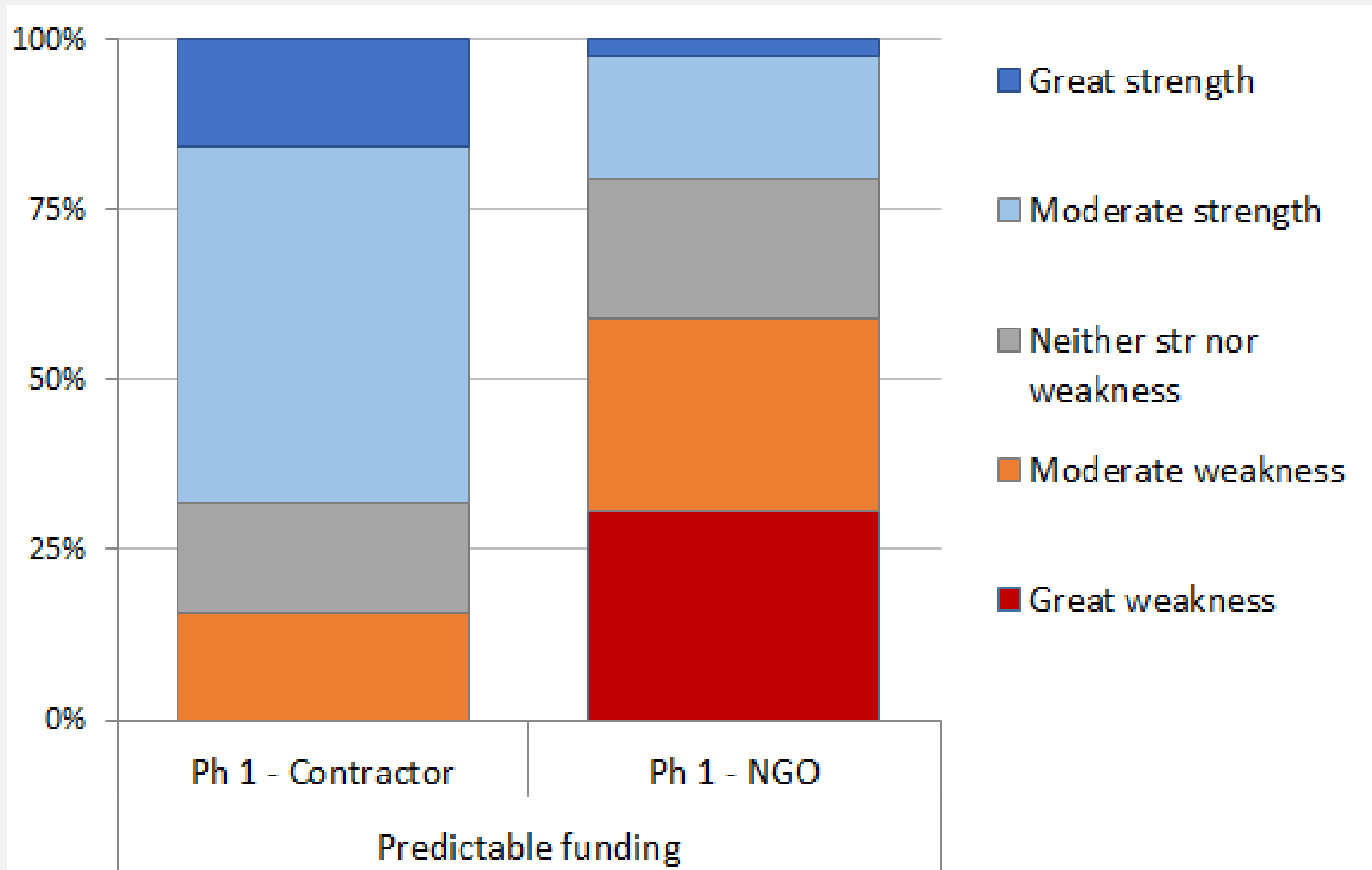

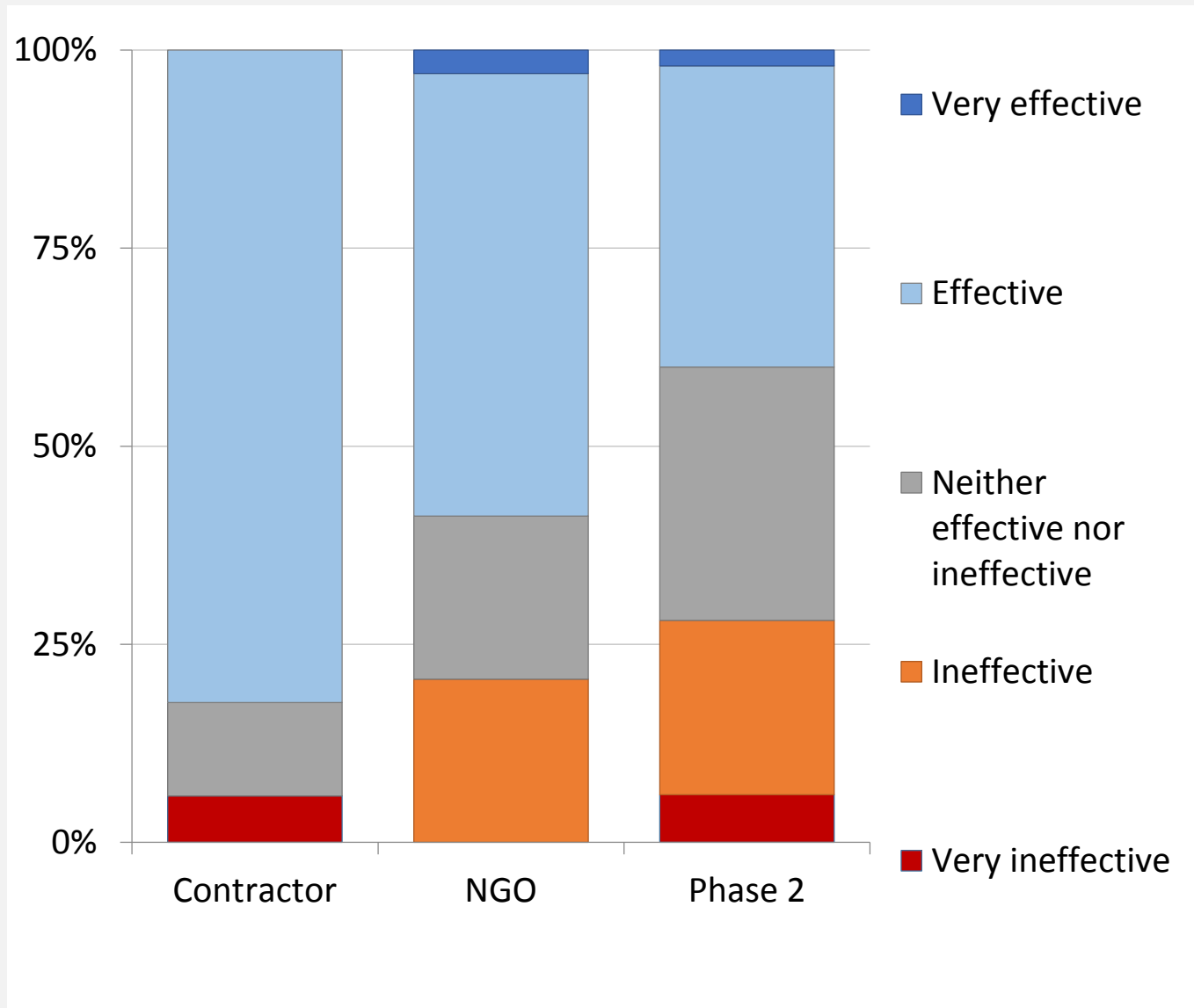

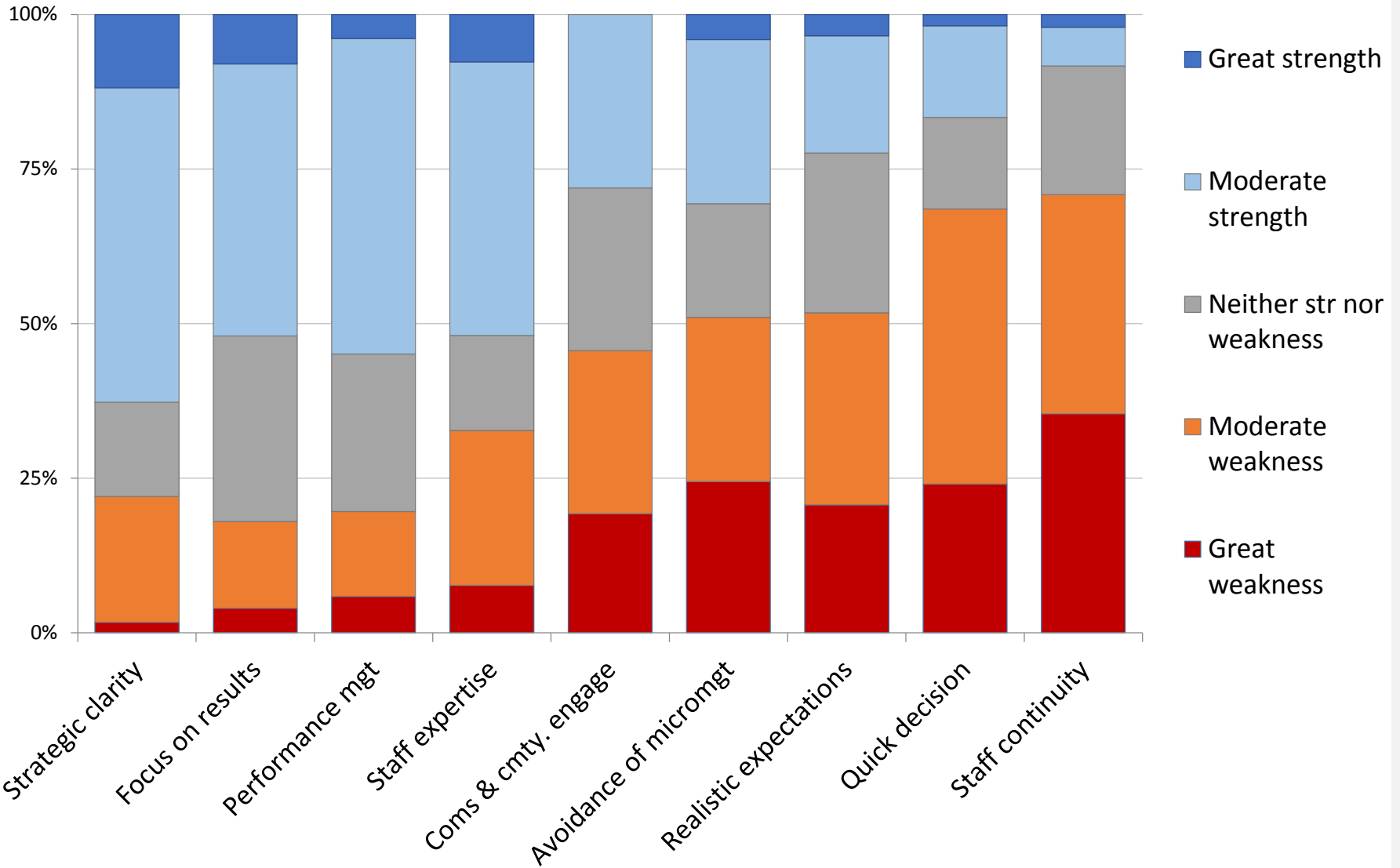
Predictable funding for some not others



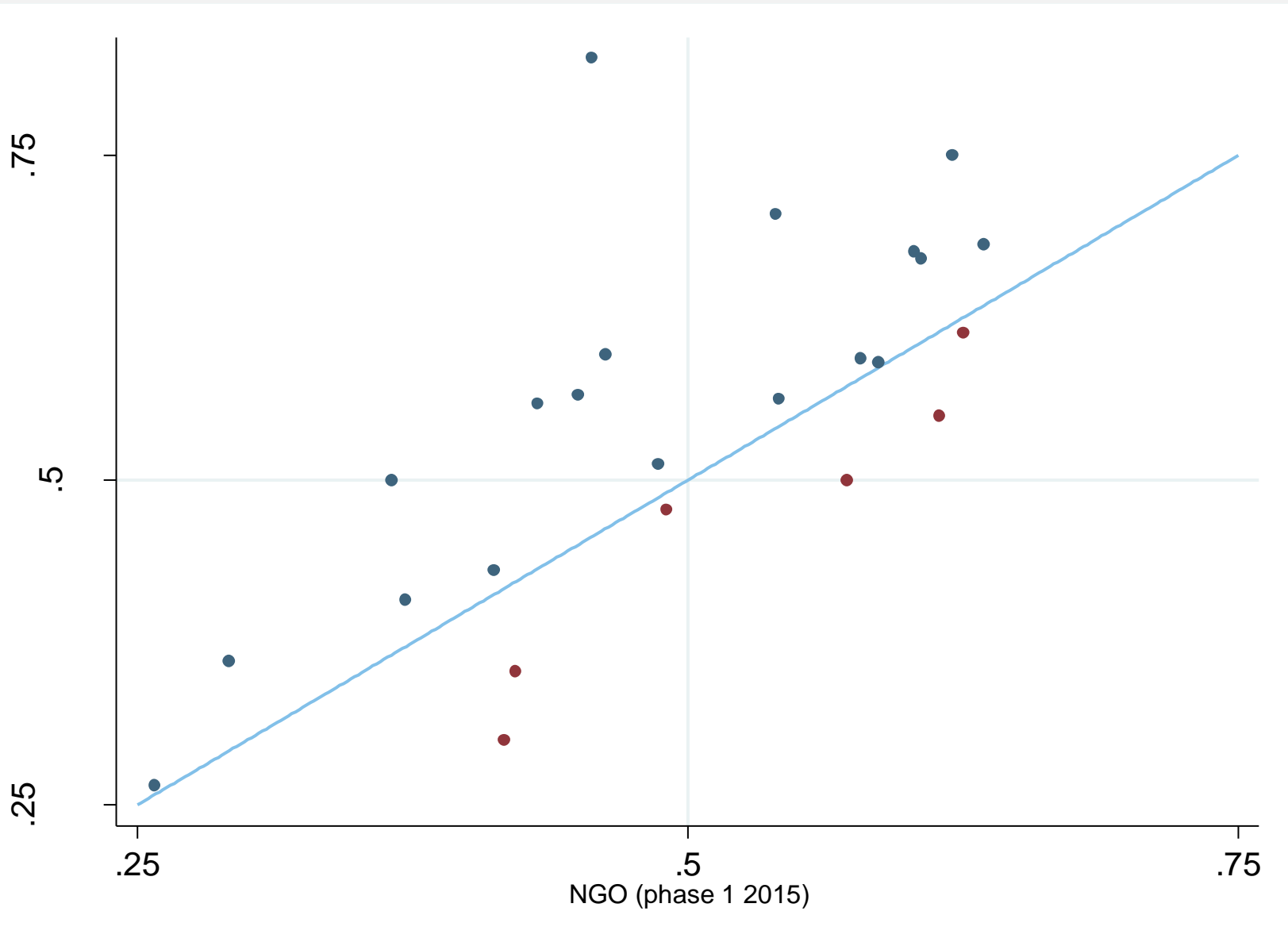
Most stakeholders thought aid programme effective



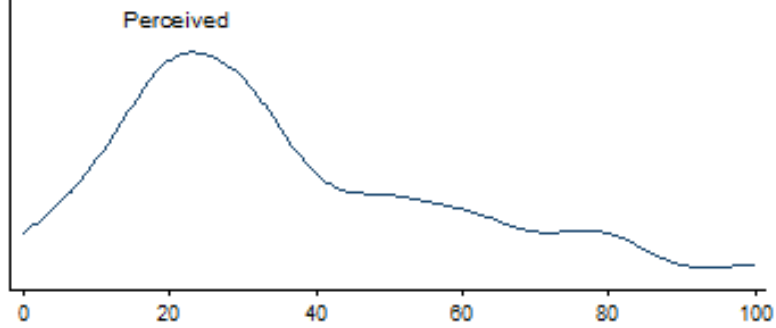
Attributes (combined Phase 1)



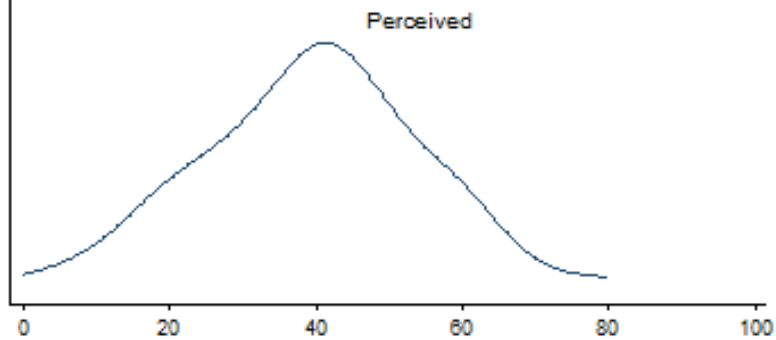
Effectiveness of attributes – (NGO v contractor)



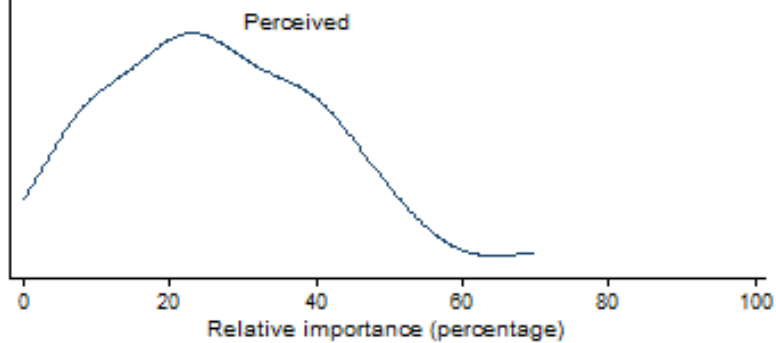
Poverty focus (Phase 1 only)



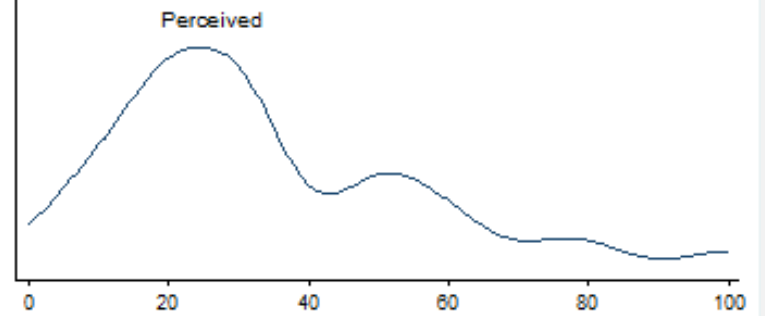
Strategic focus (Phase 1 only)



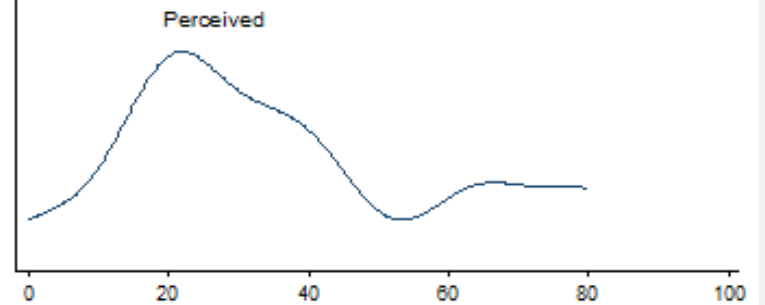
Commercial focus (Phase 1 only)



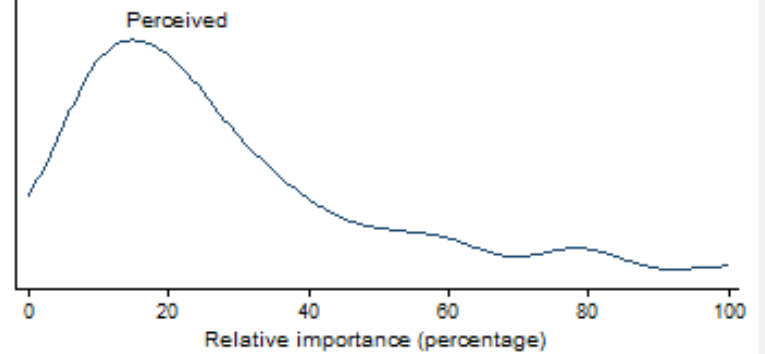
NGO Phase 1 - Poverty focus

What does all this say about the state of NZ aid?

The aid budget has been protected quite well.

Overall the aid programme is quite effective.

But there is division across stakeholders.

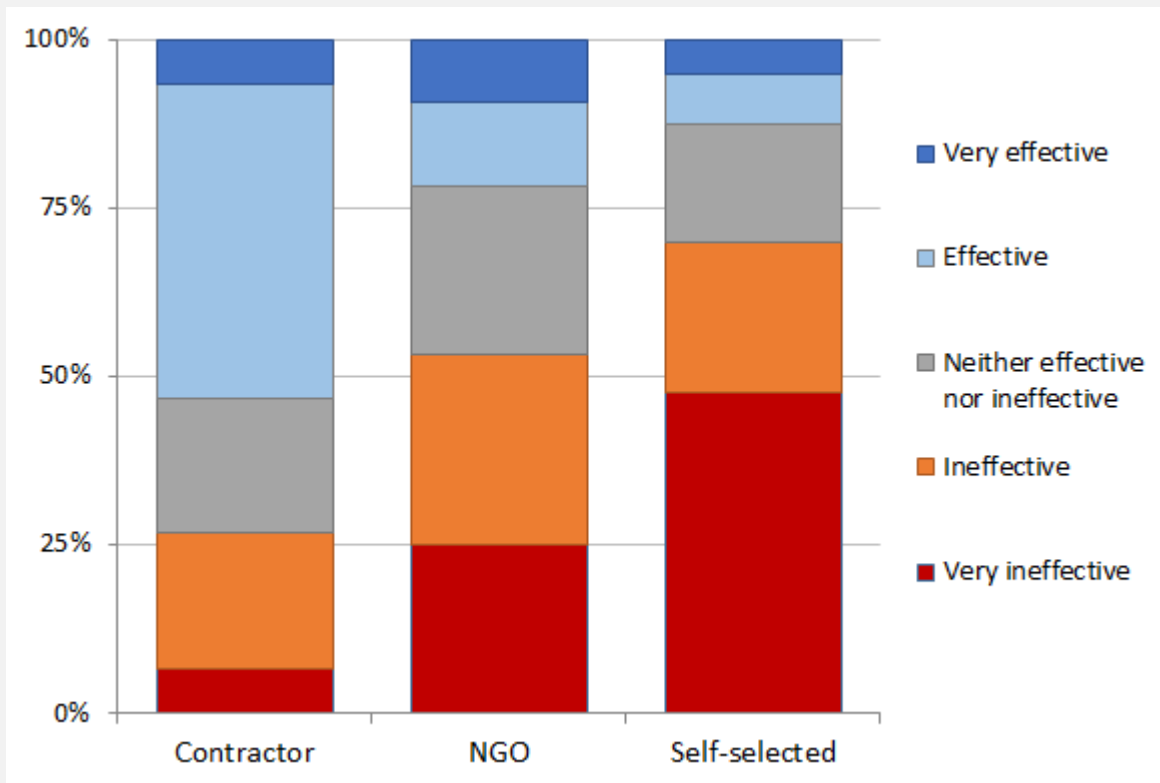
Contractors are generally more happy; NGOs quite unhappy; Phase 2 very disgruntled.

Funding predictability has been better for contractors than NGOs.

There appears to be a near unanimous belief that New Zealand aid is given largely in New Zealand's self-interest.
